The Class of 1966 Nominating Committee is pleased to present what we believe to be an outstanding slate of prospective Class Officers to lead the Class of 1966 for five years, beginning on the Sunday of our 50th Reunion and culminating with our 55th Reunion.

For Vice President: John A. Edie



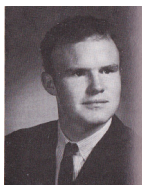
